He has particular experience of disputes in the energy & natural resources sector and/or with a connection to Africa, the Middle East, Central and Southern Asia and the wider CIS region. He also accepts appointments as an arbitrator, and is a member of the panel of arbitrators at the Asian International Arbitration Centre (AIAC) and the Russian Arbitration Centre (RAC).

Mr Dingley is currently advising a number of States, State-owned entities and private entities in investment treaty and commercial arbitration proceedings relating to sub-Saharan Africa, Eastern Europe and the wider CIS region.
