Recent cases include representing Albania in an UNCITRAL arbitration against an Italian investor in relation to a dispute in the agribusiness sector, and an African company in a dispute related to the performance of a power purchase agreement. Ms Montans has been recognised by Who's Who Legal as a Future Leader in Arbitration since 2019, which describes her as "a brilliant, sharp and responsible counsel" who "is doing a great job as arbitrator in complex cases". Ms Montans told GAR that:

Mr Ebere has worked in London, New York, Paris and Geneva at leading international arbitration practices, representing clients under most major arbitral rules with a particular focus on emerging markets.

His recent experience includes acting for sovereign States and private clients in multiple investor-state and commercial arbitrations across sub-Saharan Africa, Eastern Europe and the Middle East, including successfully representing The Gambia in three parallel ICSID arbitrations in a dispute over licensing oil blocks and acting for Ukrainian investors in an ICSID arbitration against North Macedonia concerning concession agreements in the mining sector.
